MISSION LAW EDUCATION: EMPOWERING UNDERPRIVILEGED STUDENTS IN LEGAL CAREERS

Initiative Overview: Launched in June 2021, Mission Law Education (MLE) is an NGO program aimed at supporting underprivileged youths in pursuing careers in Law. This initiative seeks to enhance diversity in legal education and the profession by focusing on students from marginalized backgrounds.

COLLABORATIVE EFFORT

MLE is a joint effort between three Delhi-based charitable organizations: Aspire India Foundation, Sir Syyed Educational Social Welfare Society, and Vision India Welfare Trust. Currently, Aspire India Foundation and Vision India Welfare Trust are actively driving the MLE program.

- **Aspire India Foundation:** Registered under Section-8 of the Company's Act, 2013, Aspire India Foundation is dedicated to holistic community development, including education, health, human rights, and vocational training, within the legal and constitutional frameworks of India.

- **Vision India Welfare Trust:** Established under the Trust Act, 1861, the Trust focuses on educational promotion, medical services, socio-economic development, and peace initiatives, particularly targeting socially and educationally disadvantaged communities.

PROGRAM EVOLUTION

The successful case of Ms. Sania Idrisi, the first beneficiary of law education support, led to the formalization and expansion of the MLE project. Ms. Sania Idrisi enrolled into Law College in 2018-19
